COUNCIL TAX DISCOUNT

For the purpose of the reduction adults who meet the under noted qualifying conditions shall be disregarded when counting the number of adults in the house.

QUALIFYING CONDITIONS : APPRENTICE

A person who, under the terms of his or her employment is:

1. Undertaking a programme of training leading to a qualification recognised by the National Council for Vocational Qualifications or the Scottish Vocational Educational Council
2. Receiving a salary and/or allowances which is:
 - a) Substantially less than that which they would receive if they had the above qualification; and
 - b) No more than £195 per week gross.

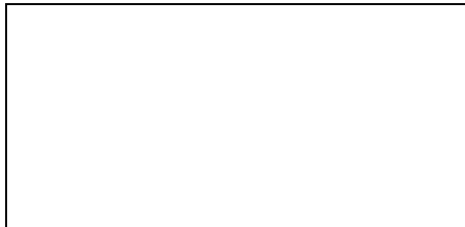
