#### **Health.**

It was reported a patient had problems picking up their prescription at Lloyds Pharmacy after 3 attempts, some prescriptions are now being sent to another source to be made up and delivered back to the chemist. Who is paying for this service?

It was also highlighted that elderly patients who may have been in hospital for a variety of reasons and received more medication can become confused with the amount of medication they need to take, they have requested to have Dossett Boxes made up to make sure they receive the correct medication at all times, especially people who have early stages of Dementia or Alzheimer's.

Only to be told by all 3 chemists that their lists are closed, despite the fact they have been longstanding customers of the particular chemist, some people have been advised to go to Hoolihans Chemist as they are the only chemist who accepts patients to their list, outwith Barrhead.
