Once again further issues have been raised about Lloyds Pharmacy

Issue 1

Customer aged 71 years old had handed in his prescription on Saturday 29th September 2018, returned the following week, to be told they did not have his prescription, they told him on several occasions that he must have handed it into another chemist, he insisted to the members of staff that he had put the prescription into Lloyds, he refused to leave until he got his prescription, however after 20 minutes another members of staff told the customer that they did in fact have the prescription, albeit they

still made him wait another 30 minutes before the prescription was made up he, received no apology from the very abrupt member of staff.

Issue 2

A 82 year old very independent customer had been in hospital after suffering a stroke, she was released from hospital with a new prescription from the hospital for new medication, she decided to go along to the chemist to have the much needed prescription filled, when she handed the prescription over she was told to come back in 2 hours, She informed the assistant that she couldn't wait 2 hours as she had just been released from hospital and needed the new medication, the assistant was very abrupt with this elderly lady and told her it was still 2hrs, another member of the public noticed the lady was distressed by the attitude of the member of staff, she drove the lady home and went back for the prescription for her 2 hours later.
