- 5. Candidates/agents may send completed nomination papers to electionoffice@eastrenfrewshire.gov.uk for an informal check prior to formal submission.
- 6. If more than one valid nomination is received, an election will be held, and voting will take place between **7.00 a.m. and 10.00 p.m. on Thursday 21 August 2025.**
- 7. Applications to register to vote **must** reach the Electoral Registration Officer, Renfrewshire Valuation Joint Board, Renfrewshire House, Cotton Street, Paisley, PA1 1AN **by midnight on Tuesday 5 August 2025.** Applications can also be made online at www.gov.uk/register-to-vote

Postal or proxy voting

- 1. Any eligible elector may apply for a postal or proxy vote at this election.
- Application for new postal votes, amendments (including amending a postal vote to a proxy vote) or cancellations of existing postal or proxy votes must reach the Electoral Registration Officer, Renfrewshire Valuation Joint Board, Renfrewshire House, Cotton Street, Paisley, PA1 1AN by 5.00 p.m. on Wednesday 6 August 2025.
- 3. Applications to vote by proxy (not postal proxy), except for emergencies at this election **must** reach the Electoral Registration Officer, Renfrewshire Valuation Joint Board, Renfrewshire House, Cotton Street, Paisley, PA1 1AN **by 5.00** p.m. on Wednesday 13 August 2025.
- 4. Applications to amend or cancel existing proxy arrangements **must** reach the Electoral Registration Officer, Renfrewshire Valuation Joint Board, Renfrewshire House, Cotton Street, Paisley, PA1 1AN **by 5.00 p.m. on Wednesday 6 August 2025.**
- 5. Applications to vote by emergency proxy at this election, i.e. made after 5.00 p.m. on Wednesday 13 August 2025 must reach the Electoral Registration Officer, Renfrewshire Valuation Joint Board, Renfrewshire House, Cotton Street, Paisley, PA1 1AN by 5.00 p.m. on Thursday 21 August 2025 on the grounds of:
 - a disability suffered after **5.00 p.m. on Wednesday 13 August 2025** (or, for applicants who suffered a disability before the deadline, their disability meant that they could not reasonably have made an application in time);
 - work/service reasons. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5.00 p.m. on Wednesday 13 August 2025**;
 - for Scottish local council elections, an elector may be able to change their proxy if their appointed proxy's circumstances have changed and they cannot reasonably be expected to vote at the polling station;
 - being detained in a hospital under the civil sections of the Mental Health (Care and Treatment) (Scotland) Act 2023; or
 - for Scottish prisoners serving a sentence of 12 months or less.
