APPROVAL OF	Minute of Meeting 15 th November 2021	
MINUTE OF MEETINGS	The Chairperson proposed the minute as a true record of the meeting and was seconded by Jane Royston and approved by the Community Council.	
MATTERS ARISING	Cllr Bamforth provided updates to the minute of 15 th November.

	Street lighting	
	"The ability to charge vehicles is a future possibility of the new smart lampposts."	
	Lighting in Broom Park	
	"Cllr Bamforth does not recall quoting £20k, but this was a figure previously noted when the request was made several years ago, to install lights, to deter young people in the park who were causing disturbances. The new proposed solar lighting will be located along both sides of the central path of the park, be less intrusive for locals and more environmentally friendly."	
	Air pollution	
	"Could it be noted that ER is closely monitoring air pollution, in accordance with Air Quality (Scotland) Amendment Regulations 2016, which is more stringent than in other areas of the UK and complies with the EU Directives."	
	Pollution monitoring and odours, particularly from the Care Home beside Aldton Park.	
	"There is a separate building within the grounds of the home which does house a biomass boiler- however the boiler is a sealed unit and feeds automatically off compressed pellets delivered into a silo within the unit.	



The operation is automatically controlled and regularly maintained. The moisture content of the pellets is also controlled on delivery.

The maintenance manager for the facility confirmed that the boiler flue or chimney was extended just after the home opened and now, also includes an additional filter to ensure even stricter control of emissions from the boiler itself. There was a fine plume of steam and possible light smoke coming from the boiler and certainly no more than would be expected from a well-maintained, correctly controlled unit burning the correct fuel.

It may be possible to arrange monitoring within the neighbour's property if they are experiencing odours or smoke from the unit but as we discussed, the area is not a smoke control zone and therefore units like the biomass boiler are permitted and we cannot guarantee that occasional low-level smoke may be detected.

In the first instance, if the resident continues to have concerns, could they be asked to keep a diary/log book of times when they are noticing odours/smoke within their property? Could they also provide comments of weather and effect at that time, this may identify a pattern to the odour (i.e. early morning/ late evening) and we can target further visits based on the recordings. The diary should be returned to the department or myself. "

Update on MCHS sports facilities

Site Works start in March 2022.

What is the scope of the work?

PRE PLANNING APPLICATION	The BKMCC have been asked to submit comments about the proposal to erect a communications mast and cabinet in Mearns Road near to the junction with Flenders Road.	
	This proposal was discussed and it was agreed that BKMCC have no objection.	
REPORT PLANNING	The Chairperson attended a Planning Democracy meeting on the 7 th December 2021:	
DEMOCRACY MEETING 7 TH DECEMBER	Scotland 2045: Draft fourth National Planning Framework – The role of the Scottish Parliament	
DECEIVIDER	There were 48 participants.	
	Planning Democracy called this meeting to alert people that NPF4 was out for consultation.	
	The first NPF1 was produced in April 2004.	
	We are now being consulted about NPF4.	
	The scope of future NPFs will be extended to include National Planning Policy. In practice, this means that the national planning policy, currently set out in the <u>Scottish</u> <u>Planning Policy</u> , will in future be set out in the NPF.	
	Future NPFs will become a formal part of every development plan, meaning that policies and proposals set in the NPF must be considered by decision makers when considering applications for planning permission.	
	The duration of future NPF's will henceforth be increased from 5 to 10 years.	
	Future NPFs will establish Minimum All-tenure Housing Land Requirements for local, city-region and national park authorities that must be reflected in the amount and location of deliverable land for future housing development identified in local development plans.

	The NPF4 sets out the Scottish Government approach to planning and development that will help to achieve a net zero, sustainable Scotland by 2045.	
	The Chairperson displayed some of the aims of the proposed NPF4:	
	 Pioneer low-carbon, resilient urban living 	
	Reinvent and future proof city centres	
	Accelerate urban greening	
	Reuse land and buildings	
	Invest in net zero housing solutions	
	Grow a wellbeing economy	
	Re-imagine development on the urban fringe	
	Improve urban accessibility	
	The definition of 'what is a 20 minute area?' was discussed but no clear definition obtained. Planning Democracy is requesting a clear definition be provided by the Scottish Government.	
	Bev Brown advised that all amenities should be within a 20 minute walk of developments. But a major concern on the part of attendees at the meeting was that such a criterion would very rarely be met under present conditions. There are major questions as to how the Scottish Government will address the concerns expressed by community groups including Community Councils.	
	In the New Year, the Chairperson and Ron Gimby will look at the draft in detail.	
	The deadline for comments is 31 st March 2022.	
RESPONSES TO COMMONPLACE	The Chairperson advised ERC's final report on the outcome of the Commonplace Questionnaire.	
QUESTIONNAIRE	"Comparatively, vehicle speed and quantity of traffic is of larger concern in Newton Mearns, Giffnock, Clarkston and Eaglesham. Narrow footways were identified here too, and in all areas, there is a clear desire for measures that will help to reduce the speed of the traffic. This may go hand in hand with re-allocating space for safer, physically distanced walking, wheeling and cycling."	
	The BKMCC noted the content and look forward to future responses from ERC.	
REPONSE TO 'GET GLASGOW	The Chairperson and other BKMCC members submitted responses to the 'Get Glasgow Moving' survey.	
MOVING' SURVEY	There is a push for a better public transport system. It was noted that such service has notably deteriorated under the	



	current Government administration.	
	Margaret Hinchliffe suggested an improvement would be to introduce a direct link from Newton Mearns to the QE Hospital. All the major hospitals could be linked with a bus service.	
	The Chairperson proposed that the BKMCC should support a resolution and submit a response to the 'Get Glasgow Moving Survey'.	
REPONSE TO ERC BUDGET	The Chairperson submitted a response to ERC Budget Consultation on December 7th.	
CONSULTATION	No acknowledgement received yet.	
	The Chairperson advised that the deadline for responses was the 12 th December 2021.	Will to advise deadline.
PARTY FOR QUEEN'S PLATINUM JUBILEE	The Chairperson suggested this item to be included in the January agenda for discussion.	
	The consensus from BKMCC members is that this is a good idea.	
WORKS IN BROOM PARK	Work has started at the part of Broom Park owned by East Renfrewshire Department of Education. This land lies to the east of Broom Park proper. The Chairperson displayed photographs of fencing around the Mearns Castle High School sports pitch.	
	Cllr. Bamforth had previously advised:
